

Admission rules for the first and second level of higher education in 2023/2024

Adopted based on subsection 13 (1) of the Higher Education Act, subsection 2³ (4) of the University of Tartu Act and clause 12 (2) 5) of the Statutes of the University of Tartu.

I. General provisions

1. The admission rules for the first and second level of higher education in 2023/2024 ('rules') govern the admission of applicants to the University of Tartu ('university') professional higher education, bachelor's studies, studies based on the integrated curricula of bachelor's and master's studies ('first level of higher education'), and master's studies ('second level of higher education') in regular and block mode studies in the 2023/2024 academic year.
2. An applicant is a person applying for degree studies at the university. An international applicant is a person who is not a citizen of Estonia and who does not hold a long-term residence permit or a permanent residence permit.
3. Citizens of Russian Federation and Belarus who cannot apply under Estonian legislation for a long-term visa or residence permit for study or do not have a valid legal basis to stay in Estonia until the end of the standard period of study of the programme are not eligible to apply for studies at the university in 2023/2024.
4. An applicant must
 - 4.1. have completed the required level of education or qualification;
 - 4.2. comply with language proficiency requirements;
 - 4.3. have completed prerequisite courses if such courses are required for a curriculum of the second level of higher education;
 - 4.4. have work experience if this is required in a curriculum of the second level of higher education;
 - 4.5. present an application and other documents required in the rules within the specified term;
 - 4.6. meet the admission requirements or special conditions of admission.
5. Students are admitted through open competition based on the schedule established by the rector.
6. One or more competitions are announced for a curriculum based on the form of study, specialisation or the place of study.
7. An applicant may apply for two competitions at the first level of higher education and two competitions at the second level of higher education.
8. The university has the right not to open studies in curricula in which fewer than ten applicants have accepted the admission within the term specified in the admission schedule, and in specialisations in which fewer than five applicants have accepted the admission. In order not to open studies, the dean submits a reasoned request to the admission steering committee within three working days after the deadline set in the admission schedule for students to accept or decline the admission. The admission steering committee makes the decision not to open the studies within three working days. The decision is adopted if at least two thirds of the steering committee members vote in favour. The decision is communicated to applicants and published at www.ut.ee/sisseastumine and www.ut.ee/admissions. An applicant who has

declined another student place to start studies in a curriculum in which the university does not open the studies will be admitted to the other student place.

9. A competition organised by a partner university under a cooperation agreement for a joint curriculum or a cross-border curriculum is considered equivalent to an open competition organised by the University of Tartu. The university verifies the applicants' compliance with conditions set out in clause 4.1.
10. International applicants who have completed the previous level of education in a foreign country pay the fee for processing admission documents 100 euros (incl. VAT) per person. The fee must be paid by the deadline for submitting applications as provided in the admission schedule. The fee for processing admission documents is non-refundable, except to applicants who accepted a student place but studies are not opened for a reason specified in clause 8.
11. Exemption from the fee of processing admission documents is granted to international applicants who
 - 11.1. apply for studies in the same curriculum under which they were admitted in the previous year and have submitted the application documents to the university on paper, or
 - 11.2. were matriculated to the same level of higher education in the 2020/2021 academic year or later.
12. Admission to the university is organised
 - 12.1. on the basis of a threshold value;
 - 12.2. on the basis of a ranking list;
 - 12.3. under special conditions.
13. A threshold value is the minimum score received for compliance with a particular curriculum's admission requirements ensuring the admission of the applicant.
14. The applicants' ranking list is formed based on points received for compliance with the admission requirements of a particular curriculum.
15. Special conditions of admission ('special conditions') are criteria which, if fulfilled, ensure the admission of an applicant without considering the curriculum's admission requirements.
16. Admission requirements by curricula are established in annexes 1 and 2 to these rules.
17. Compliance with admission and special requirements is evaluated in points. The highest possible score is 100 points.
18. Each admission requirement accounts for a certain percentage of the highest possible score. An applicant's score (p) is calculated as follows: the result of an admission requirement (a) is multiplied by the relevant percentage (b); in the event of several admission requirements (n), the products are added up and the total is divided by 100.
Formula: $p = (a_1 \cdot b_1 + a_2 \cdot b_2 + \dots + a_n \cdot b_n) / 100$. The score is rounded to two decimal places.
19. An applicant who meets the requirements for admission under special conditions is given the maximum score, except if the applicant meets the special conditions of the academic aptitude test as established in clause 73.1.2 or the special conditions provided in annex 1 to these rules, and applies for studies in a programme to which students are admitted on the basis of a threshold value. In this case, the applicant's score is the points of the threshold value as established in annex 1.
20. If the score given for meeting the special conditions is lower than the score calculated for compliance with the admission requirements, the score calculated for complying with admission requirements is taken into account.

21. In an Estonian-taught curriculum, the applicants have to certify their Estonian language proficiency at least at level B2, except in cases specified in clauses 23 and 24. The required level of Estonian language proficiency is proved by
 - 21.1. basic education, secondary education, vocational education or higher education completed in Estonian;
 - 21.2. a certificate of Estonian language proficiency at level B2 or C1, or the result of the state exam in Estonian as a second language at least at level B2;
 - 21.3. the final exam results in the Estonian language of an International Baccalaureate diploma curriculum ('IB') or the European Baccalaureate curriculum of the European School ('EB');
 - 21.4. the university's test of Estonian as the language of instruction.
22. An applicant admitted to an Estonian-taught curriculum, who has graduated from a school in which the language of instruction is not Estonian and whose Estonian language proficiency exam result at level B2 was below 80 points or state exam result in Estonian as a second language below 80 points, must before registration for first-year courses take a test of Estonian as the language of instruction at the university pursuant to the procedure established in the Study Regulations.
23. At the first level of higher education, international applicants applying for the curricula "Information Technology Systems Development", "Languages and Multilingualism in School" or "Youth Work" do not have to certify their Estonian language proficiency at least at level B2. An international applicant who does not have proficiency in Estonian at least at level B2 must, if admitted, study Estonian in an intensive language course of 60 ECTS. In this case, the applicant must provide proof of Russian language proficiency at least at level B2.
24. Applicants who have completed an intensive language course in Estonian at the university in the 2022/2023 academic year must, for an Estonian-taught curriculum, certify their Estonian language proficiency at least at level B1. The required level of Estonian language proficiency is proved by a certificate of Estonian language proficiency at level B1 or the university's test of Estonian as the language of instruction.
25. When an applicant to the curriculum of Medicine (in Estonian), Special Education and Speech Therapy, Dentistry or Pharmacy certifies their Estonian language proficiency with the result of the state exam in Estonian as a second language or the exam of Estonian language at level B2, its result must be at least 80 points.
26. In non-Estonian-taught curricula, applicants must prove proficiency in the language of instruction at least at level B2.
27. The university reassesses the following study results of applicants that are needed for compliance with admission requirements:
 - 27.1. results of the previous level of education completed in a foreign country;
 - 27.2. IB results;
 - 27.3. EB results;
 - 27.4. results of the Scholastic Aptitude Test ('SAT');
 - 27.5. results of BioMedical Admissions Test ('BMAT');
 - 27.6. results of the Estonian language proficiency exam.
28. The vice rector for academic affairs establishes
 - 28.1. the principles for conversion of grades received on a five-point scale to a hundred-point scale;
 - 28.2. the principles of reassessment of study results specified in clauses 27.1–27.6 of the rules;
 - 28.3. the possible methods of certifying language proficiency provided in clauses 23 and 26.

II. Submission of application and other documents

29. To apply to the university, applicants submit their application and documents ('documents') electronically or on paper. The list of the required documents is set in annex 3 to the rules.
30. Electronic application and documents are submitted via the admissions information system at www.sais.ee or the admissions system for international students at www.estonia.dreamapply.com. Paper application and documents are submitted to the student admissions unit of the university's Office of Academic Affairs in Tartu, to Narva College, Pärnu College, Viljandi Culture Academy, or the university's office in Tallinn.
31. Electronically submitted documents must be digitally signed or authenticated with a digital signature or stamp. Paper documents are submitted as
 - 31.1. an original document and a copy or
 - 31.2. a transcript certified by a notary or the issuer.
32. Documents are submitted in Estonian or English. Documents that are not in Estonian or English must be accompanied by a translation into Estonian or English, translated by a sworn translator or certified by the issuer or a notary.
33. To verify and clarify the information included in the documents, the university has the right to use its study information system, the Estonian Education Information System and the International Baccalaureate Information System database, request information from educational and other institutions and submit documents certifying education to the Estonian ENIC/NARIC, the academic recognition information centre of the Estonian Education and Youth Board, for assessment of the qualification.
34. The university has the right to reject the applicant's application if
 - 34.1. the information included in the application is incomplete or incorrect;
 - 34.2. the applicant's level of education or qualification does not enable access to studies at the desired level of higher education;
 - 34.3. the applicant has submitted forged documents;
 - 34.4. the applicant does not submit all the required documents by the specified date;
 - 34.5. the applicant does not pay the fee for processing admission documents specified in clause 10 by the due date.
35. The documents submitted upon applying, except original graduation certificates, are not returned.
36. The information necessary for application is published at www.ut.ee/sisseastumine and www.ut.ee/admissions.

III. Entrance exams

37. Entrance exams may consist in
 - 37.1. 37.1. an exam taken at the university or by electronic means, e.g. a professional suitability test, academic aptitude test or entrance interview;
 - 37.2. 37.2. a written exam paper, e.g. a motivation letter, essay or portfolio. In the case of a written exam paper, the admissions committee has a right to conduct an interview with the applicant to specify information provided in the paper. An applicant does not have the right to demand an interview.
38. The schedule of entrance exams and the requirements for the content and organisation of entrance exams approved by the dean are published at www.ut.ee/admissions on the date specified in the admission schedule.
39. If the admission requirements of a curriculum include several entrance exams among which

the applicant must choose, the applicant may choose only one of them. If an entrance exam is organised more than once a year, the applicant may take it on one occasion only.

40. Applicants must register for the academic aptitude test at www.ut.ee/sisseastumine. Applicants who have acquired secondary education or acquire it in the 2022/2023 academic year can register to take the academic aptitude test. The academic aptitude test is organised on the dates specified in the admission schedule. Based on an applicant's request, the result of the academic aptitude test may be replaced by the result of an SAT taken by the applicant in the 2022/2023 academic year. For the substitution, the applicant needs to present a SAT certificate.
41. Applicants applying for the second level of higher education who have received a call for conscript service have the right to take the entrance exam prior to the entrance exam period. An application together with the copy of the call-up for conscript service must be submitted to the chair of the admission committee by 15 June 2023.
42. To take an exam specified in clause 37.1 of the rules, an applicant presents an identity document.
43. The highest possible score for an entrance exam is 100 points. An entrance exam is graded with an accuracy of up to two decimal points.
44. The entrance exam result is positive if the student's score is at least 51.
45. If more than one entrance exam is required for admission, the candidate is allowed to take the next exam if the score for the previous exam is at least 51 points.
46. The results of the entrance exams are published on the date specified in the admission schedule at www.sais.ee.
47. An applicant has the right to access the exam paper on site at the university within two weeks of the disclosure of the result.
48. The entrance exam papers are not returned to the applicant and are retained until the beginning of the 2023/2024 academic year.
49. Entrance exam results are only valid in the year of taking the exam.
50. The chair of the admission committee
 - 50.1. has the right to allow an applicant who has not appeared at an entrance exam with good reason to take the exam at another time during the entrance exam period;
 - 50.2. must remove an applicant who has committed academic fraud from an entrance exam and not consider the applicant's exam paper;
 - 50.3. has the right to adapt an entrance exam for applicants with special needs according to the nature of the special need.
51. An applicant must notify the admission committee of a good reason for failure to appear at the exam specified in clause 37.1 on the exam date at the latest.

IV. Filling student places

52. The rector establishes the number of student places by curricula or by competitions. The rector may also set an admission number which is larger than the number of student places and within which it is possible to admit applicants by the date specified in the admission schedule. If more student places become vacant after that date, twice as many applicants as there are vacant student places may be admitted.
53. The university admits an applicant who complies with
 - 53.1. all admission requirements in case of admission on the basis of a threshold value and whose score received for complying with the admission requirements exceeds, or equals to, the threshold established in annex 1 and 2;

- 53.2. all admission requirements in case of admission by ranking and whose place in the ranking list is within the number of student places established by the rector according to clause 52 of the rules, or complies with the conditions provided in clause 52 about filling student places after the date specified in the admission schedule;
- 53.3. the special conditions established in the rules.
54. An applicant does not comply with the admission requirements
 - 54.1. if their entrance exam result is below 51 points, in case the admission requirements of the curriculum include an entrance exam;
 - 54.2. if their score for admission requirements is below 66 points.
55. If there are vacant student places in a curriculum where applicants are admitted on the basis of a threshold value, the places are filled based on a ranking list.
56. The student places of applicants admitted under special conditions are included in the number of student places established by the rector pursuant to clause 52 of the rules.
57. The university has the right to revoke an admission decision
 - 57.1. with the resolution of the head of student admissions, if it appears that
 - 57.1.1. the applicant's level of education or qualification does not enable access to studies at the desired level of higher education;
 - 57.1.2. the applicant who is a citizen of Russian Federation or Belarus does not have a right under current legislation to apply for a long-term visa or residence permit for study or does not have a valid legal basis to stay in Estonia until the end of the standard period of study of the curriculum;
 - 57.1.3. the applicant is not issued a long-term visa or residence permit for study;
 - 57.1.4. the applicant has submitted forged documents or false information;
 - 57.1.5. the applicant has committed academic fraud at an entrance exam or
 - 57.1.6. the applicant has overdue payments to the university.
 - 57.2. with the resolution of the admission steering committee on the proposal of the vice rector for academic affairs, if the applicant has considerably violated generally accepted norms of conduct or academic practice.
58. The university is not liable for possible material or non-material damage resulting from the revocation of an admission decision.
59. The university informs the admitted applicants of the admission decision at www.sais.ee or www.estonia.dreamapply.com on the date specified in the admission schedule.
60. An applicant who has been admitted is required to notify the university of accepting the student place at www.sais.ee or www.estonia.dreamapply.com or by a written application to the Office of Academic Affairs within the period specified in the admission schedule. Failure to notify within the prescribed term is considered a renouncement of the student place, and the vacant student place is offered to the next applicant in the ranking list.
61. Student places that have remained vacant during the admission are filled until the date specified in the admission schedule.
62. An applicant who has been admitted to the university and has notified the university of accepting the student place is matriculated. Applicants who are not citizens of the member states of the European Union or the European Economic Area or Switzerland must, after announcement of the admission decision and before matriculation to a student-funded student place in a non-Estonian-taught curriculum, pay half of the tuition fee for the first semester pursuant to the Conditions and procedure of reimbursement of degree study costs.

63. If the student does not start to study or renounces the student place, the fee mentioned in clause 62 is not returned, except if
- 63.1. the university revokes the admission decision based on clause 57.1.1 or 57.1.2;
 - 63.2. the applicant's Estonian visa application is declined and the applicant can prove it with a document in a format reproducible in writing;
 - 63.3. the applicant is matriculated to a free student place.

V. Admission to the first level of higher education

64. A person with secondary education or an equivalent qualification has the right to apply for studies at the first level of higher education. A person who has completed an IB programme has the right to apply, if they graduated with a diploma.
65. The admission requirements for the first level of higher education may include
- 65.1. a state exam;
 - 65.2. (average) grade on the graduation certificate;
 - 65.3. professional suitability and prior learning and work experience;
 - 65.4. entrance exam;
 - 65.5. SAT result;
 - 65.6. BMAT result.
66. If the admission requirements include the result of the state exam in Estonian as a second language, it can be replaced by the result of the Estonian language proficiency exam at least at level B2. If an applicant has acquired basic education in Estonian, the university will not take into account the result of the state exam of Estonian as a second language or the Estonian language proficiency exam.
67. If the admission requirements include the result of the state exam in narrow mathematics, it can be replaced by the result of the state exam in broad mathematics. In this case, 16 points are added to the state exam result in broad mathematics, considering that the maximum result of the state exam in broad mathematics including the extra points can be 100 points. If the admission requirements of a competition include the result of the state exam in broad mathematics, it cannot be replaced by the result of the state exam in narrow mathematics. The result of the state exam in mathematics taken until 2013 is considered equal to the result of the state exam in broad mathematics.
68. The results of the state exam in Estonian, narrow mathematics and broad mathematics can be replaced the respective IB or EB results or final exam results obtained when completing secondary education in a foreign country. An applicant who has completed secondary education in a foreign country may replace the result of the state exam in Estonian by the result of the final exam in the language of instruction of the school or in the first foreign language.
69. An applicant who does not have the result of a state exam that has been established as an admission requirement may take an entrance exam to meet the admission requirements, if an entrance exam is provided in annex 1 to the rules. An applicant who has taken the required state exam cannot apply based on the entrance exam result only.
70. For calculating the average grade of the graduation certificate, the following compulsory subjects of the national curriculum for upper secondary schools are taken into account: Estonian (Russian or another language in a school where Estonian is taught as a second language), literature, Estonian as a second language, foreign language at level B2, foreign language at level B1, narrow or broad mathematics, geography (nature or human geography), biology, chemistry, physics, history, personal, social and health education, civics and citizenship education, music, arts and physical education.

71. Extra admission points

71.1. In Estonian-taught curricula, three points are added to the score of a gymnasium graduate with a gold and silver medal, based on the regulation of the minister of education and research “Regulations for giving recognition to students”, or an applicant who has completed a vocational secondary programme with distinction, based on the regulation “Conditions of completion of a vocational secondary education with distinction”. If an applicant has completed both the gymnasium with a medal and the vocational secondary education programme with distinction, three points are added to the applicant’s score.

71.2. Up to five points are added to the score of an applicant who has completed a course or a massive open online course (‘MOOC’) at the university or the University of Tartu Youth Academy (‘youth academy’) not earlier than the 2018/2019 academic year. The vice rector for academic affairs determines the courses for which extra points are granted by curricula. To receive extra points, an applicant must pass the course at least for the grade C or, in the case of non-differentiated evaluation, with a “pass”. The number of extra points is equal to the credit point value of the course. The highest total score for the completion of multiple courses is five points.

72. Applicants are admitted on the basis of a threshold value and on the basis of a ranking list in accordance with annex 1.

73. Admission under special conditions

73.1. The university admits students under special conditions to curricula specified in annex 1 to the rules:

73.1.1. based on the results of an Olympiad or competition pursuant to the terms and procedure established in annex 4;

73.1.2. students whose academic aptitude test score is 65 points or higher, and who have taken the test on the dates specified in the admission schedule;

73.1.3. up to twelve applicants selected in a competition organised by the University of Tartu Academic Sports Club (‘academic sports club’) pursuant to the conditions and procedure established in annex 5.

73.2. In addition to the special conditions specified in clauses 73.1.1–73.1.3, the university may establish special conditions in annex 1 to the rules.

73.3. An applicant who is admitted under special conditions must meet the requirements specified in clause 4.

73.4. An applicant has the right to apply based on the result of an Olympiad or competition established in clause 73.1.1 and annex 1, if the applicant has not been matriculated to the university under the same grounds before.

VI. Admission to the second level of higher education

74. A person who holds a nationally recognised bachelor’s degree or equivalent qualification has the right to apply for the second level of higher education, except if a one-year master’s curriculum requires a higher level of education. If the completion of prerequisite courses or previous work experience is required to apply for a curriculum of the second level of higher education, an applicant who meets the requirement has the right to apply.

75. If prerequisite courses have been established for admission to a curriculum, and an applicant has not completed a curriculum specified in clause 85, the applicant must request assessment of prior learning and/or work experience in the application. Assessment of compliance of prerequisite courses can also be requested outside the admission period.

76. The committee for recognising prior learning and work experience (‘RPL committee’) makes

a decision on recognising the applicant's prior learning and/or work experience and communicates the decision to the technical admission committee by the date specified in the admission schedule.

77. The admission requirements at the second level of higher education may include
 - 77.1. the average grade of the previous level of study (prerequisite courses);
 - 77.2. the grade of the graduation thesis or final exam of the previous level of study;
 - 77.3. the average grade of studies that form the basis for application;
 - 77.4. prior learning and work experience;
 - 77.5. entrance exam.
78. The average grade of the previous level of study for Estonian-taught curricula is the weighted average of all positive exam results, and for non-Estonian-taught curricula, the arithmetic average of all positive exam results, unless other exam results to be taken into account have been specified in annex 2 to the rules. If the applicant has not completed studies at the previous level of study by the moment of applying, the average grade of the previous level of study is for Estonian-taught curricula the weighted average of the positive exam results of the period of study preceding the semester of submission of the application, and for non-Estonian-taught curricula, respectively, the arithmetic average. The average grade is calculated with an accuracy of up to two decimal points.
79. Applicants are admitted based on a threshold value and based on a ranking list in accordance with annex 2. The ranking list for admission to the curriculum Excellence in Analytical Chemistry is compiled based on the requirements of the Erasmus Mundus Joint Master Degrees measure of the European Commission's Erasmus+ programme, available at www.each.ut.ee.
80. Admission under special conditions
 - 80.1. The university admits up to twelve applicants selected as a result of a competition organised by the academic sports club to study under special conditions in curricula specified in annex 2 and pursuant to the terms and procedure provided in annex 5.
 - 80.2. In addition to the special conditions specified in clause 80.1, the university may establish special conditions in annex 2 to the rules.
 - 80.3. An applicant who is admitted under special conditions must meet the requirements specified in clause 4.
81. In Estonian-taught curricula, three points are added to the score of an applicant who has graduated cum laude from one or more higher education curricula.

VII. Appealing admissions-related decisions

82. To contest an entrance exam result, a written appeal is submitted to the vice rector for academic affairs no later than on the working day following the announcement of exam results. The appeal is reviewed by the appeals committee formed by the vice rector for academic affairs and comprising at least the chair of the admission committee and a member of the admission steering committee. The committee makes a decision within three working days after the submission of the appeal. The decision is immediately communicated to the appellant.
83. Other admissions-related decisions and acts can be appealed by submitting a written appeal to the vice rector for academic affairs within five working days of the publication of the decision or doing the act. The vice rector for academic affairs may forward the appeal for review and decision to the admission steering committee who reviews the appeal and makes the decision following the procedure established by the rector. The vice rector for academic affairs or the committee makes a decision within seven working days of the submission of the appeal. The decision is immediately communicated to the applicant.

VIII. Implementing provisions

84. The dean approves the requirements for the content and organisation of entrance exams and other admission requirements by 1 December 2022. The vice rector for academic affairs approves the content and organisation of the academic aptitude test by 1 December 2022.
85. In the case of curricula with prerequisite courses for admission, the respective information is published on the university website. By 1 December 2022, the RPL committee determines the curricula which meet the requirements of prerequisites for application to curricula of the second level of higher education and the graduates of which do not need to apply for assessment of the prerequisite.
86. Vice rector for academic affairs
 - 86.1. establishes by 1 December 2022
 - 86.1.1. the principles of reassessment and the language proficiency requirements as provided in clause 28;
 - 86.1.2. the youth academy courses and MOOCs, the completion of which gives applicants extra points;
 - 86.2. forms by 1 February 2023 a committee tasked with evaluating the applicants of the competition for admitting athletes under special conditions;
 - 86.3. forms by 9 June 2023
 - 86.3.1. based on dean's proposals, admission committees tasked with organising entrance exams, calculating the applicants' average grade of the previous level of study, reassessing the study results of applicants who have completed secondary or higher education in a foreign country, and assessing the applicants' compliance with the admission requirements of the second level of higher education;
 - 86.3.2. the technical committee tasked with organising the admission of applications and documents.
87. The rector
 - 87.1. establishes the admission schedule by 1 December 2022;
 - 87.2. establishes the number of student places and admissions by curricula and competitions by 1 December 2022;
 - 87.3. forms by 1 February 2023 the admission steering committee comprising at least eight members and tasked with observing compliance with the rules and deciding matters not governed by the rules.

If data necessary for applying are not available for the university from public registries via the admissions information system, the applicant also submits the following documents:
 - 1.1. a document certifying secondary education and the results report. An applicant who has completed secondary education in a foreign country, in the absence of certificate of secondary education, submits a transcript of records first and the certificate of secondary education by 1 November 2023;
 - 1.2. an identity document or a copy thereof;
 - 1.3. a document certifying the change of name in case an applicant has changed their name;
 - 1.4. a state exam certificate if the curriculum's admission requirements include a state exam;
 - 1.5. a certificate of Estonian language proficiency at level B2 or C1 to replace the result of state exam in Estonian as a second language;
 - 1.6. a document certifying Estonian language proficiency at least at level B2 when applying for an Estonian-taught curriculum;
 - 1.7. a document certifying English language proficiency at least at level B2 when applying for an English-taught curriculum;
 - 1.8. a document certifying Russian language proficiency at least at level B2 when applying for a Russian-taught curriculum, or the Russian language proficiency must be proved according to clause 23 of the rules;
 - 1.9. a document certifying French language proficiency at the level specified in annex 1 to the rules when applying for admission under special conditions to study French Language and Literature in the curriculum of Romance Studies;

If data necessary for applying are not available for the university from public registries via the admissions information system, the applicant also submits the following documents:
 - 3.1. a diploma and diploma supplement of the previous level of study. An applicant who has completed higher education in a foreign country, in the absence of a diploma and diploma supplement of the previous level of study, first submits a transcript of records first and then the diploma and diploma supplement by 1 November 2023;
 - 3.2. an identity document or a copy thereof;
 - 3.3. a document certifying the change of name in case an applicant has changed their name;
 - 3.4. a diploma and diploma supplement, certificate of continuing education or a standard description of previous work experience of an applicant who applies for the assessment of prerequisite courses;
 - 3.5. a certificate regarding the compliance of prior learning and/or work experience with admission requirements if the applicant has applied for the assessment of compliance of prerequisite courses from an institute or college before the admission period;
 - 3.6. a document certifying Estonian language proficiency at least at level B2 when applying for an Estonian-taught curriculum;

 - 1.2. as a year 11 or 12 student ranked in the top two in at least one topic of the final round of the Estonian national Olympiad in history among year 11 or year 12 students, and in the top ten in the overall ranking for that topic;
 - 1.3. as a year 11 or 12 student participated in an international Olympiad;
 - 1.4. as a year 11 or 12 student achieved one of the top three prizes in the National Contest of Young Scientists;
 - 1.5. as a year 11 or 12 student achieved one of the top three prizes in the competition of environmental research;
 - 1.6. as a year 11 or 12 student achieved one of the top three prizes for a research project in the history research competition;
 - 1.7. as a year 11 or 12 student won the first prize in the Estonian Secondary and Basic School Debating Championships or the Estonian Secondary and Basic School Debating Championships in Russian in team competition, or one of the top three places in individual competition;
 - 1.8. as a year 11 or 12 student belonged to the winning team in Estonia's Best Student Company competition;
 - 1.9. as a year 11 or 12 student belonged to the team that won the first prize in the national phase of the European Statistics Competition;
 - 1.10. won one of the top three places in the Rakett 69 television programme.

TERMS AND PROCEDURE FOR ADMISSION OF ATHLETES UNDER SPECIAL CONDITIONS

1. The University of Tartu Academic Sports Club ('sports club') organises a competition to select up to twelve athletes who may take up studies at the University of Tartu at the first or second level of higher education under special conditions as set out in the rules.
2. The competition is open to active athletes of Estonia and foreign countries, who have achieved top results at the international level in the field of sports or who have the potential to reach such level.
3. The sports club announces the competition on the website sport.ut.ee by 1 February 2023. Applications are accepted from 20 February to 10 March 2023. Applicants are informed of the results of the competition by email by 31 March 2023.
4. The applicants must submit the following documents:
 - 4.1. an application to participate in the competition;
 - 4.2. a certificate issued by the sports federation regarding the applicant's athletic achievements;
 - 4.3. a motivation letter, which gives an overview of the applicant's sports activities so far, presents the applicant's athletic goals and explains the choice of curriculum indicated in the application;
 - 4.4. documents certifying the completion of the previous level of study with diploma supplement or, if the applicant completes the previous level of education in the summer of the competition, a transcript of records;
 - 4.5. a document certifying proficiency in the language of instruction;
 - 4.6. a copy of identification document.
5. In addition, the applicant may submit a recommendation letter of the national olympic committee or sports federation.
6. Applicants are evaluated by a six-member committee, comprising one representative of the sports club, of the student admissions unit of the Office of Academic Affairs, and of each faculty of the university. The composition of the committee is approved by the vice rector for academic affairs.
7. The committee assesses the applicants and makes the decision, considering the following:
 - 7.1. applicant's athletic career so far, athletic achievements and development potential;
 - 7.2. engagement in fields of sports that are (priority) fields of the sports club;
 - 7.3. willingness to represent the sports club;
 - 7.4. receipt of the performance sports grant of the Estonian Olympic Committee;
 - 7.5. suitability for studies in the curriculum or curricula indicated in the application, based on the motivation letter and the document certifying the completion of the previous level of education, with diploma supplement.
8. The committee has a right to conduct an interview with the applicant. An applicant does not have the right to demand an interview.
